
Counselling is available for:





Directors' Report

It is with deep gratitude and honour that we present this year's Director's Report on behalf of the Board of Directors, Executive Director, and Director of Operations of Envision Counselling & Support Centre Inc. As a longstanding pillar of support across Southeast Saskatchewan, we remain steadfast in our commitment to collaborative efforts that empower individuals and foster healthier communities—communities free from violence and rooted in mental wellness.

Over the past year, we deepened our community engagement through events like the Family Expo in Estevan, White Bear Wellness Fair, Weyburn Communithon, and Estevan United Way Telethon. Envision played an important role in the planning and delivery of the Courage and Community Mental Health Dinner and joined the Mayor's Luncheon in Weyburn, further building our local presence. In response to rising suicide rates, we joined the Southeast Hub Steering Committee to help develop a regional action plan, resulting in a coordinated media campaign highlighting mental health supports and promoting our services. We also supported national and provincial initiatives, amplifying vital messages around healing, safety, and resilience.

Our reach continues to grow to meet the evolving needs of our service area. This year, we established a regular counselling presence at Bear Claw Casino and expanded our delivery of workshops and presentations to Indigenous communities, including Ocean Man, White Bear, and Pheasant Rump Nakota First Nations. Our Oxbow office relocated to its new home within the RM of Enniskillen's Wellness Centre, and our Family Support team in Weyburn established a satellite office in the Metro Centre, increasing accessibility to vital supports. Significant investments continue to be made in staff development, resulting in enhanced quality and consistency of care. Training provided to our team included specialized training in Violent Threat Risk Assessment (VTRA), Sand Tray Therapy, Suicide Protocols, Trauma-Infused Anti-Racism, De-escalation Techniques, Professional Boundaries, and Grief Counselling.

Throughout the year, Envision staff facilitated presentations, groups, and workshops for a wide variety of partners including Southeast Regional College, SHA, libraries, minor sports associations, schools, and newcomer family programs. We facilitated another successful Women's Empowerment Group and piloted a men's support group in Weyburn, in collaboration with a local private counsellor, and continue to build strong, values-aligned relationships with agencies such as EPYC, the Estevan and Weyburn Chambers of Commerce, and the United Way.

This year, we strengthened our communications and public engagement through media training, an all-staff marketing session, and the creation of a promotional video with Access Regina. We also began updating media protocols and messaging guidelines. With the addition of a Fundraising Specialist, we're now exploring fresh campaign ideas in collaboration with local media and community partners.

Ongoing infrastructure improvements have been a priority, with renovations made in both the Carlyle and Weyburn offices to better support client and staff needs. Our leadership continues to be represented in provincial networks through participation in strategic planning with PATHS and Family Service Saskatchewan, helping to shape the future of service delivery on a broader scale.

Throughout the year, our organization demonstrated exceptional fiscal management, ensuring that every dollar entrusted to us was used efficiently and transparently to further our mission. By implementing rigorous budgeting practices, closely monitoring expenditures, and pursuing strategic cost-saving initiatives, we maximized the impact of donor contributions while maintaining full compliance with financial regulations. Our commitment to accountability and stewardship was further reflected in our clean audit results and strengthened financial reserves, positioning us for continued stability and growth in the years ahead.

As we reflect on this year's accomplishments, we are deeply thankful for the unwavering support of our clients, communities, staff, and funding partners. It is through these collective efforts that we continue to foster safety, dignity, and healing. We look ahead with hope and determination as we strive to make meaningful and lasting impacts across Southeast Saskatchewan.



Drove **207,194** km and worked **8,583.60** hours to support clients within our Family Support Program.




Provided **389** therapeutic counselling sessions through our new Children, Youth and their Caregivers Rapid Access Counselling program.
